# GPDP- INTRODUCTION

- Based on fourteenth finance commission's (FFC) recommendations, a sizable amount of untied grants will be distributed to Gram Panchayats across the country in support for providing basic services.
- An enormous opportunity for responsive local governance at the Gram Panchayat level.
- In order to properly utilize and manage the funds for benefit of people, the Gram Panchayat needs to prepare a comprehensive gram panchayat development plan (GPDP).
- In the context of the constitutional mandate, this plan has to be participatory involving the community, particularly the Gram Sabha, in the formulation of priorities and projects.
- The GPDP will have to have a clear component addressing the vulnerabilities of poor and marginalised people and their livelihood opportunities.

# MINISTRY GUIDELINES

## MoPR Directives

- In a letter from MoPR dated February 4<sup>th</sup>, 2016 to Principal Secretary/Secretary of Panchayati Raj Department of State/UTs it was mandated to promote SHG federations in preparation of GPDP in consultation with the PRIs
- GPs to accord priority to SHGs in accessing common resources
- SHGs to be involved in delivery of services
- SHGs to prepare and submit Micro Credit Plan to the GP which will be incorporated with GPDP
- SHGs to be engaged in Gram Sabha processes from publicity, facilitation to documentation

## MoRD Directives

- In a letter from MoRD dated April 22<sup>nd</sup>, 2016 to Principal Secretary/Secretary of Rural Development Department of State/UTs it was mandated to promote SHG federations in preparation of GPDP in consultation with the PRIs
- SHGs in consultation with GPs to prepare a Poverty Reduction Plan as a part of GPDP where demands of the SHGs will be given a priority
- GPs to use SHG network for strengthening Gram Sabha
- Promote SHGs for community monitoring, service delivery and implementation of developmental initiatives
- Facilitate quarterly joint meetings of SHGs and PRIs for discussing the various demands of the federations

# NRLM'S SHG NETWORK

- NRLM's SHGs and their federation, as institutions of poor have a key role in the planning for and implementation of interventions of economic development and social justice
- The SHG network is responsible for participating in Gram Sabha and other platforms of the Panchayat, provide feedback through community monitoring and support GP in their developmental initiatives and planning processes
- Keeping this in mind, MoPR and MoRD jointly decided to promote and institutionalize PRI-CBO Convergence
- This is where the PRI-CBO Convergence project becomes relevant.

# PRI-CBO CONVERGENCE

The PRI-CBO Convergence project has created resources in the form of local resource groups in each pilot GP.


The project has provided various trainings to

- GP members on their role and responsibilities in local development
- SHGs and their federations on their rights and entitlements and participate in local governance through platforms such as Gram Sabhas and Ward Sabhas.
- The project also works towards forming linkages and a working relationship between community based organizations (CBO) and GP.
- The participatory process envisioned in GPDP and the processes within PRI-CBO Convergence project are related and complementary to one another.
- KS-NRO will be supporting partner states for integration of PRI-CBO Convergence with GPDP.

# POVERTY REDUCTION PLAN

- In a letter from Secretary, MoPR dated 13<sup>th</sup> August, 2018, it was mandated that the process of GPDP will be participatory. For this the process of GPDP will be done through a series of Gram Sabha
- Gram Sabhas are going to be conducted from 2<sup>nd</sup> October 2018 to 31<sup>st</sup> December 2018 for preparation of GPDP
- In a letter from MoRD dated 7<sup>th</sup> September, 2018 it was mandated that the SRLMs will ensure that the demand plan will be prepared by the SHG network and presented in the GPDP Gram Sabhas
- A template for Poverty Reduction Plan which will be the demand plan from the SHG was prepared and circulated to the SRLMs

# COMPONENTS OF POVERTY REDUCTION PLAN (2/2)

- **Entitlement Plan :** Contains detail of the number of SHG members eligible for various entitlements such as Pension, MGNREGA etc.
- **Livelihood Plan:** Contains detail of the SHG member who wants undertake activity such as agriculture, horticulture, cottage industry etc. in a individual or group activity
- **Public Goods and Services Plan:** Contains detail about construction or repair of the work/institution such as road, AWC etc.
- **Individual Infrastructure Plan:** Contains detail of the SHG member who wants to build or repair structures such as IHHL, NADEP Pit, Cattle Shed etc.

# ASSAM

- Assam is in the process of preparing GP2RP in the PRI-CBO Convergence blocks to integrate it with the GPDP plan.
- It was decided to conduct three Gram Sabhas in Assam - October 2nd 2018, the second one in the first week of November 2018 and the last one in November 3rd - 4th week for the final submission of demand plans from the community.
- ASRLM, along with SIRD decided that the CBO will prepare the demand plan as GP2RP in the project blocks. ie, Bajiagaon, Laharighat , Barhampur, Lawkhowa , Dhekiajuli and Borcolla.
- The entitlement demand was submitted on the October 2nd Gram Sabha and the GP2RP plan will be presented in the second Gram Sabha and the final GP2RP plan will be submitted at the 3<sup>rd</sup> Gram Sabha.
